



## Australian International Law Journal ('AILJ') - Publication Policy

### 1. Introduction

This sets out the terms under which you (the author or joint author) agree (on your own behalf and on behalf of any joint author/s) to permit the International Law Association (Australian Branch) Incorporated ('ILA') to publish and reproduce your manuscript (article, note or review) and to permit third parties to do so.

No amendment shall be made to this policy without express written consent of the Editor-in-Chief.

### 2. Your copyright

Copyright in your manuscript is vested in you and the ILA. You grant the ILA a licence to publish and reproduce your manuscript and to permit third parties to do so on the terms stated below.

### 3. Authorship

By submitting your manuscript to the ILA you warrant that:

- (a) The manuscript is an original work created solely by you and any joint author/s and that no part of the manuscript violates any copyright;
- (b) If you refer to material not created solely by you and any joint author/s, such material is properly attributed to its respective author/s/source;
- (c) generative artificial intelligence has not been used to create any text in the manuscript that has been attributed to you and any joint author/s as author/s;
- (d) The manuscript has not already been substantially published elsewhere;
- (e) The manuscript has not been submitted for publication elsewhere, and will not be submitted for publication elsewhere until the Editor-in-Chief confirms in writing that the manuscript will not be published in the AILJ;
- (f) The manuscript is not defamatory; and
- (g) The manuscript does not infringe any other law or rights of any third party.

You agree to indemnify the ILA and all members of the editorial committee for any loss or damage arising from the breach of any of these warranties or for any liability which may arise in connection with the publication or reproduction of your manuscript.

### 4. Publication and Reproduction

The ILA encourages dissemination of articles, case notes and book reviews published in the AILJ. For example, in addition to publication of the AILJ in printed form, the ILA may publish or reproduce your manuscript on the internet or through on-line databases such as Austlii, LexisNexis and Westlaw.

You license the ILA (without charge) to publish and reproduce your manuscript in any format and allow third parties to do so on such terms as the Editor-in-Chief or the President of the ILA thinks fit.

### **5. Subsequent Republication of Your Manuscript by You**

Although copyright in manuscripts is jointly held by the authors and the ILA, if you or any joint author/s wish to republish your manuscript elsewhere after it is published in the AIJ you undertake to obtain the permission in advance of the Editor-in-Chief to do so. Such permission will normally be granted provided prior publication of the manuscript in the AIJ is expressly acknowledged in the republished manuscript.

You are free to make copies of the final published version of your manuscript as long as you distribute such copies at or below cost.

### **6. Review of Your Manuscript**

You agree that the Editor-in-Chief's decision on whether to publish your manuscript in the AIJ shall be final. You should not treat any other communication from the ILA as an undertaking to publish your manuscript.

In addition to reviews by the members of the editorial board and committee, manuscripts may be sent for review to external reviewers. Although the members of the editorial committee attempt to expedite this process, it may take some time before we can let you know whether or not your manuscript has been accepted for publication.

A member or members of the editorial committee will edit your manuscript to correct any spelling or syntax errors, to put footnotes into house style and, on occasion, to enhance expression or clarify meaning. You authorise the members of the editorial committee to do so without seeking your prior approval. Members of the editorial committee will normally consult an author before making any major change.

### **7. Governing Law**

The law of the State of New South Wales applies to this policy.

### **8. Agreement**

By your submission of your manuscript you agree to the terms of this policy on your own behalf and (where relevant) on behalf of any joint author/s. You also warrant that you are authorised by the joint author/s to agree (by the submission of your manuscript) to the terms of this policy on behalf of the joint author/s.
